1.	<b>Pedagogics</b>	To acquaint students with the basic concepts, problems and the subject of research of pedagogy as a theory of education and upbringing. Presentation of issues: upbringing and development, types and styles of upbringing, difficult situations and upbringing problems, behavioral disorders, information society and knowledge society, contemporary pedagogical trends and directions.	3
2.	<b>Introduction to psychology</b>	During the classes, the basic issues of psychology, important in the context of social work, are discussed. The importance of psychology as an applied science is presented and emphasized - the student has the opportunity to expand their self-knowledge and increase their soft skills.	3
3.	<b>Introduction to social work</b>	The student will receive knowledge in the field of scientific disciplines (sociology, psychology, pedagogy, economics, law) forming the theoretical basis of social work. Thanks to this, in the future he will be able to make a multi-faceted diagnosis of the family and social situation of social welfare clients.	3
4.	<b>Sociology</b>	The aim of the classes is to provide basic knowledge about the basics of sociology, social problems, macro and microstructures, social changes, their impact on society and the ability to construct clear and understandable statements using specialized concepts in the field of sociology.	3

5.	<b>Methodology of social work</b>	<p>During the course, he / she will receive basic knowledge of scientific disciplines that form the theoretical basis for social work, necessary for further methodical work with the client. This knowledge will be supplemented with knowledge about institutions and organizations of social welfare, health service, labor market, education, and others in which a social worker performs his work or with which he cooperates.</p>	3
6.	<b>Elder and disabled person assistant</b>	<p>The subject shows the tasks of an assistant for an elderly and disabled person - the legal basis for the functioning of assistants in a family experiencing difficulties, a family assistant, an assistant for a disabled person, a caretaker of an elderly person, an assistant for an elderly and a disabled person, differences between the concepts of "assistant" and "caregiver".</p>	3
7.	<b>Social exclusion</b>	<p>During the course the student will receive sociological, psychological and pedagogical knowledge that will allow to understand the social processes leading to the marginalization and social exclusion of groups and individuals. They will learn the basic definitions of social exclusion, have knowledge of the dimensions of exclusion, will acquire knowledge to characterize an individual and socially excluded group, know how to minimize this phenomenon and how to support the excluded.</p>	3
8.	<b>Organization of social assistance</b>	<p>The aim of the course is to introduce students to the issues of social welfare organization as an institution of the social policy of the state. Students will gain knowledge about the organization of social assistance, its role in the social security system and the tasks of individual institutions in the context of legal regulations, economic situation, and contemporary social problems.</p>	3

9.	<b>Guidance</b>	The aim of the course is to prepare students of social work to carry out professional tasks in the field of social counseling and specialist counseling: educational, family, vocational, legal, psychological, rehabilitation.	4
10.	<b>Monographic lecture</b>	The monographic lecture aims to familiarize the student with the specific dimensions of social work and the functioning of a social worker in the closer and more distant socio-economic environment.	3
